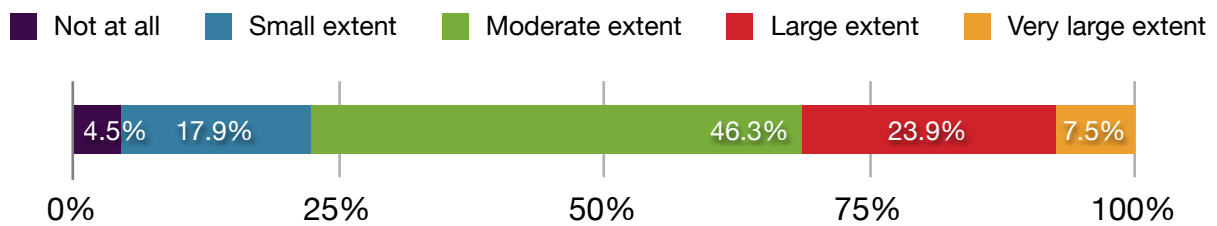

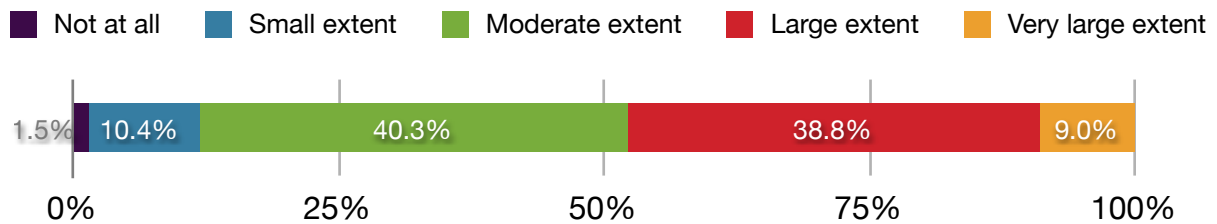

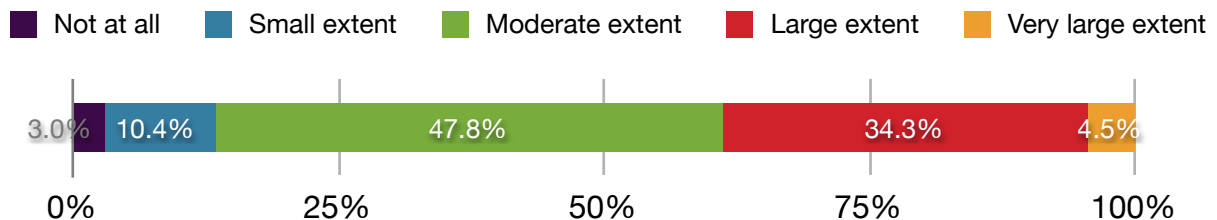
a) Shown that they care about your learning outcomes?



b) Been helpful and approachable?



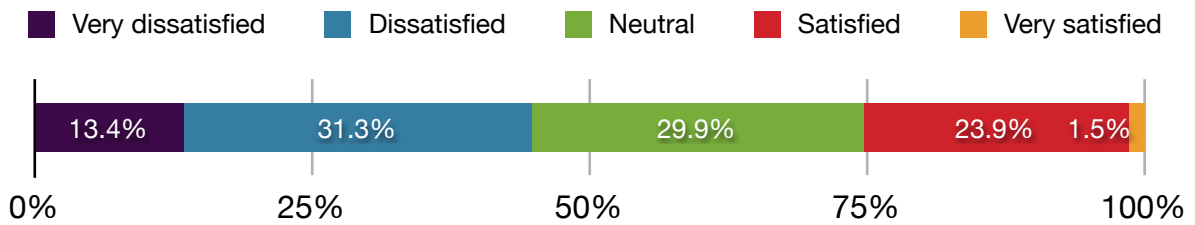
c) Created an engaging learning environment?



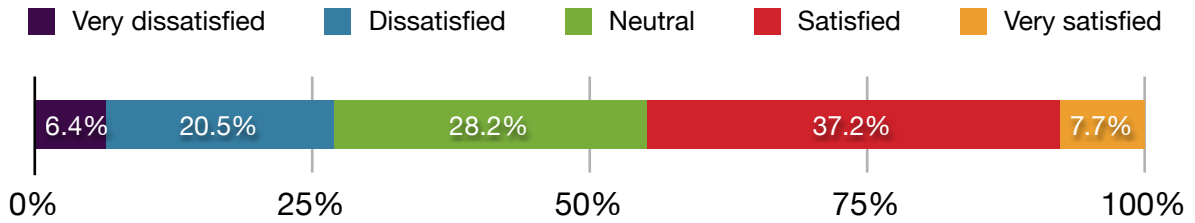

a) The quality of the feedback that you receive on assessments?

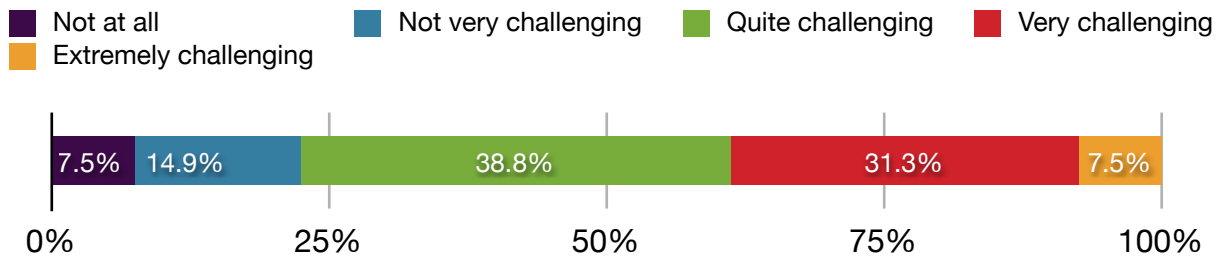


b) the timeliness of the feedback that you receive on assessments?



Question 14: How challenging have you found your assessments?

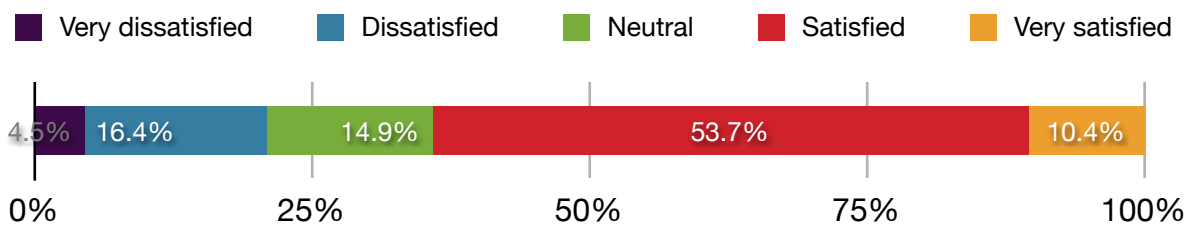

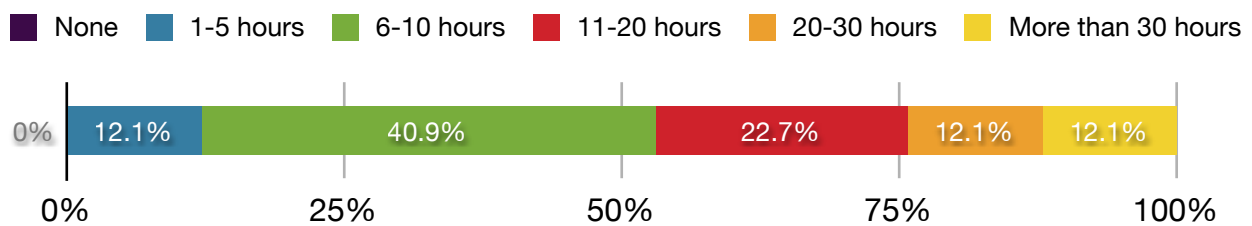

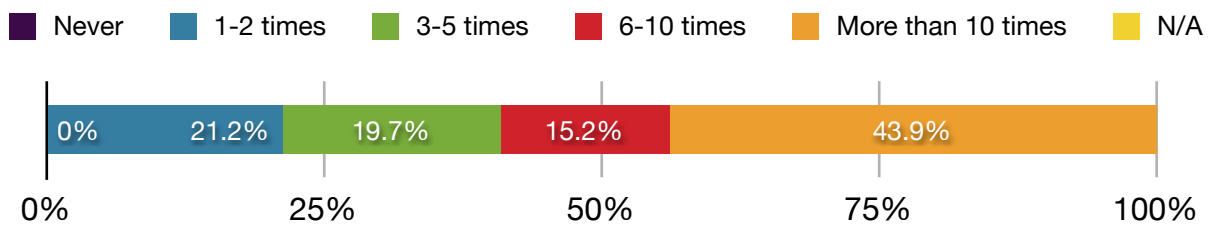
Question 16: During semester, how many hours do you spend studying (including preparing for class) each week?

Question 17: How often do you visit your law school/university library (as opposed to using online library resources) in a typical semester?

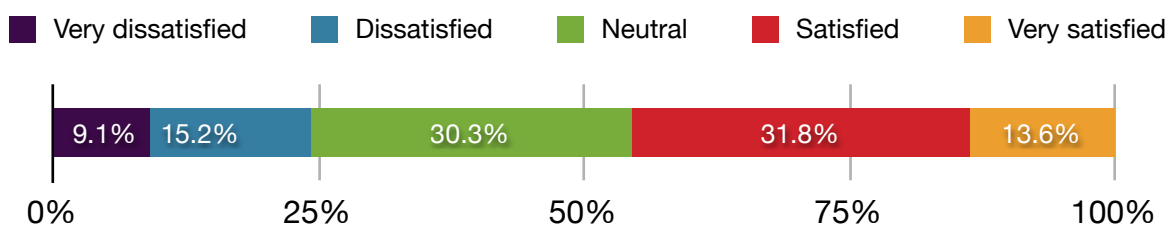

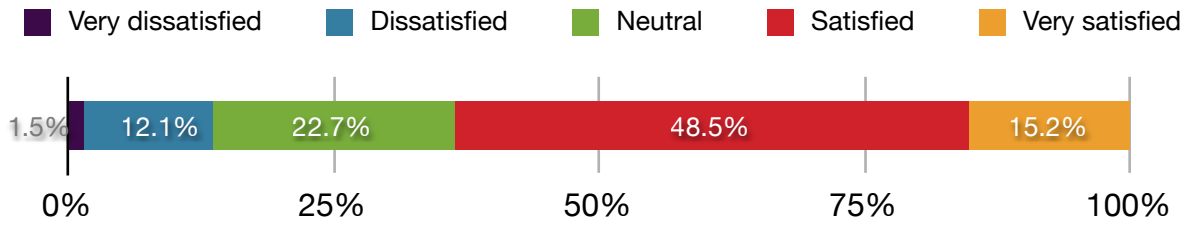

a) The range of elective subjects available?



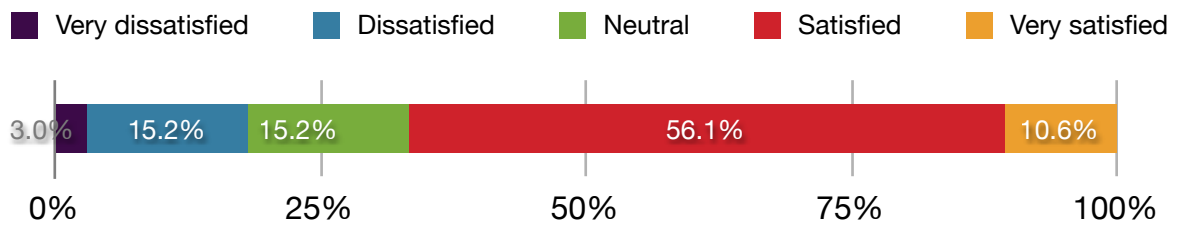
b) The online resources available to support your study, such as study forums?

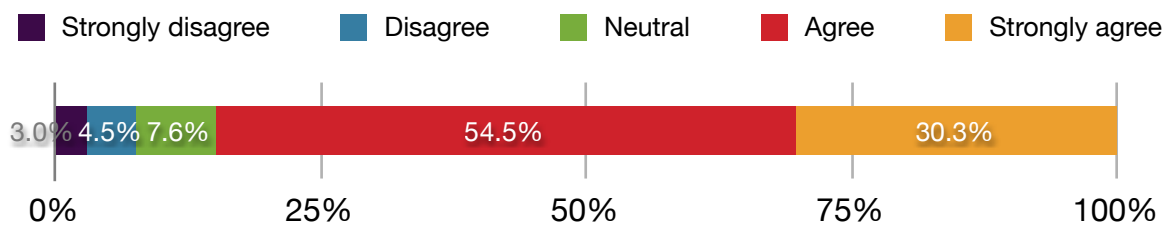

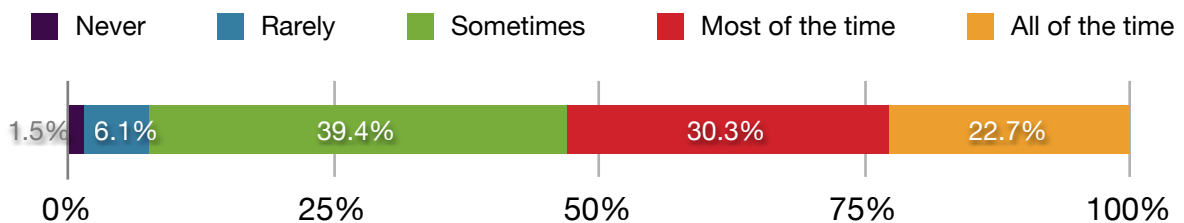
Question 20: I believe my law school is highly regarded by employers.

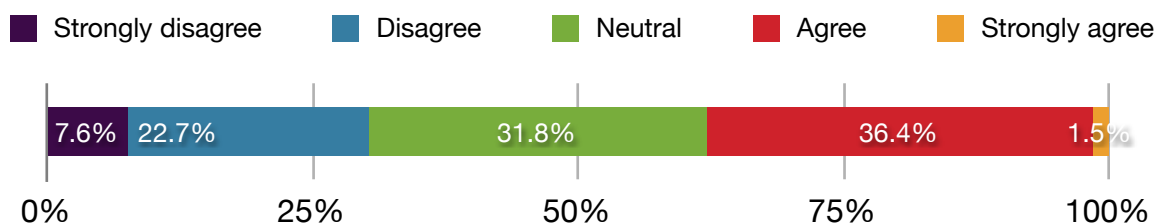
Question 21: How often do you feel stressed about finding a relevant job after you graduate?

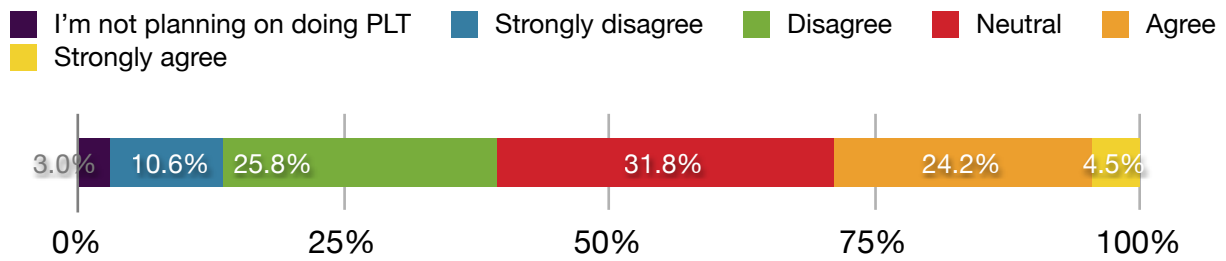
Question 22: My law school provides sufficient information about work experience/employment opportunities.

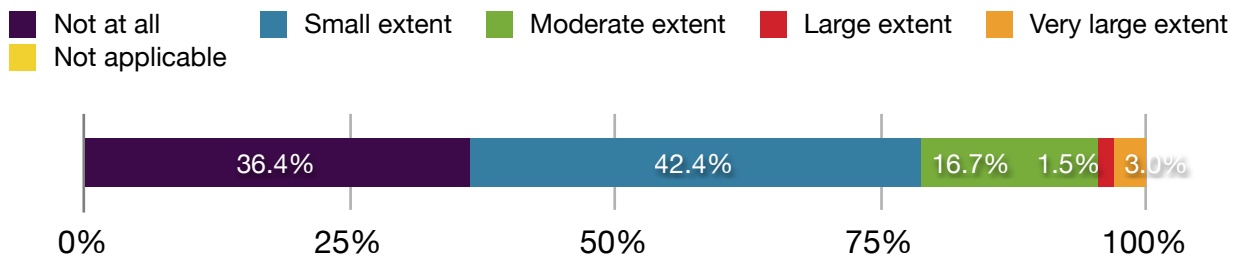
Question 23: I have access to sufficient information about my practical legal training (PLT) options for when I finish my degree.

Question 24: To what extent have you used career support services at your university?

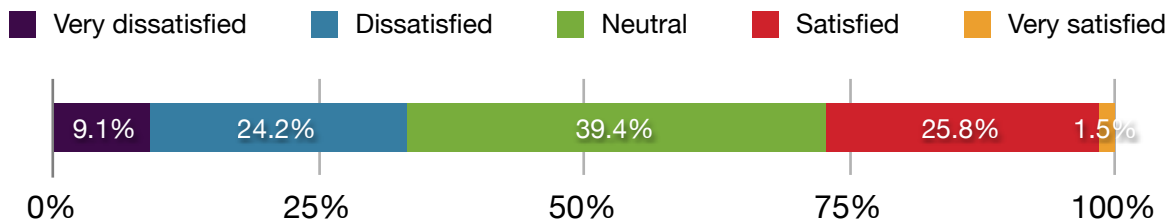

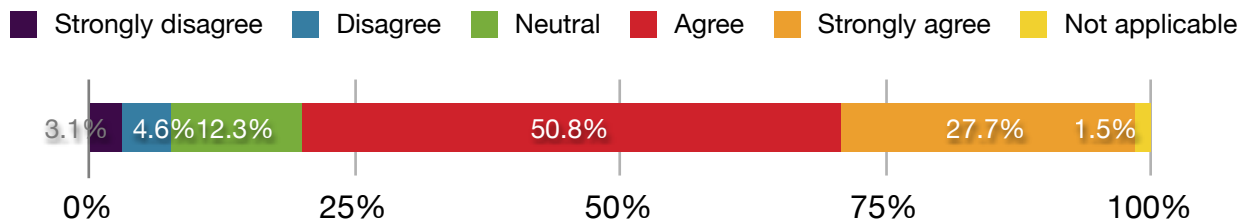

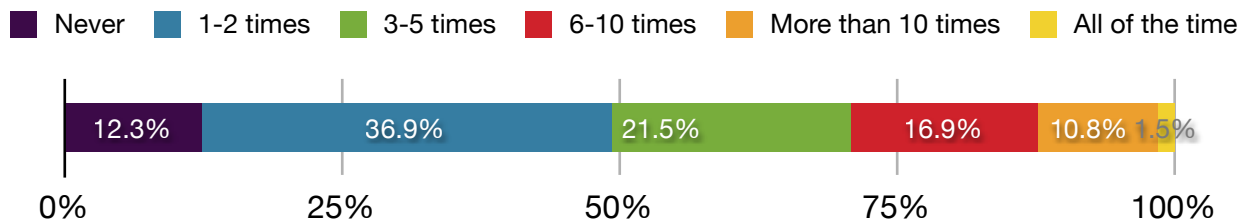
Question 26: I enjoy spending time on campus at my law school

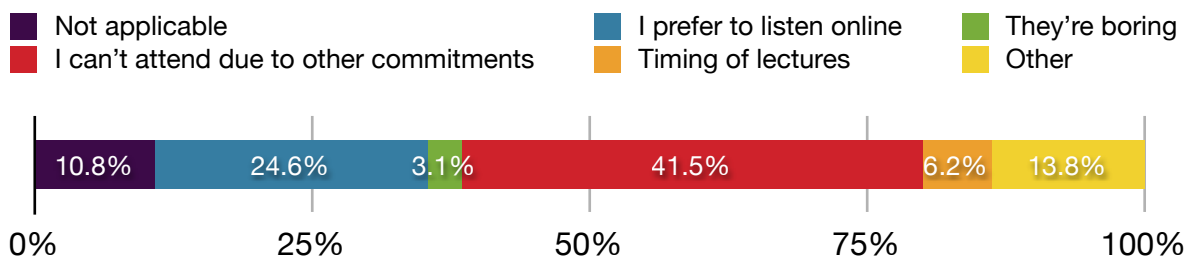
Question 27: How often do you skip lectures in a typical semester, other than as a result of illness?

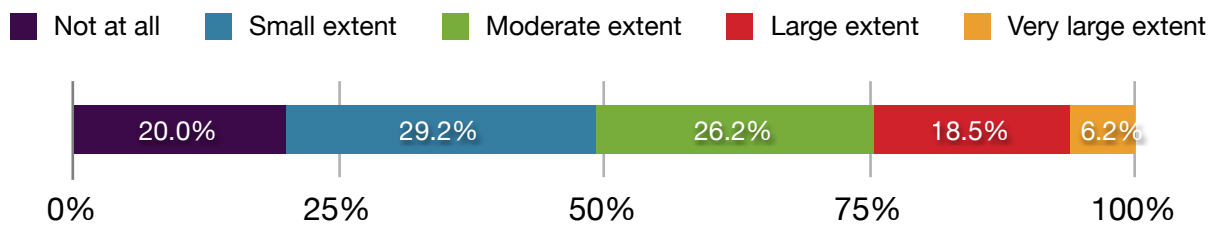
Question 28: What is your main reason for skipping lectures?

Question 29: To what extent have you taken part in extra-curricular activities such as legal competitions, social events and clubs at your law school?

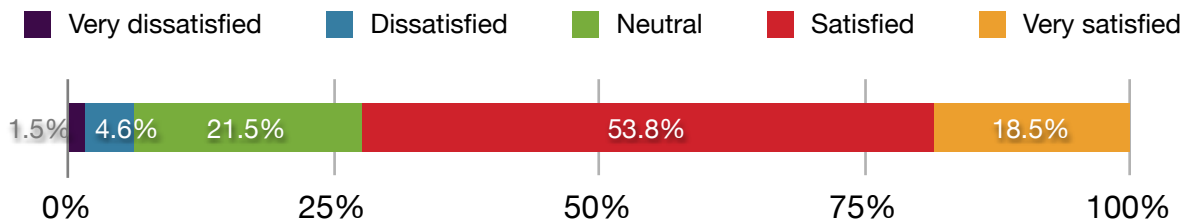

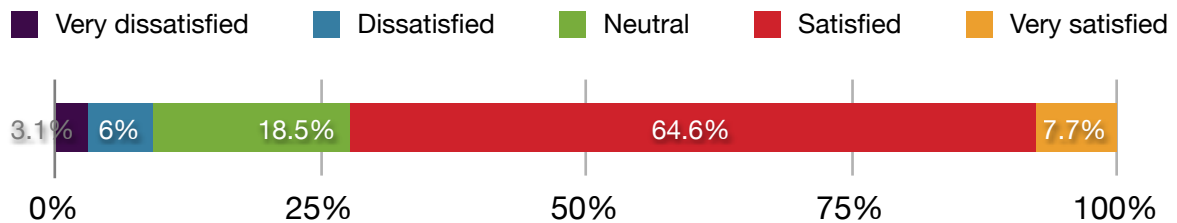

a) the range of extra-curricular activities available at your law school?



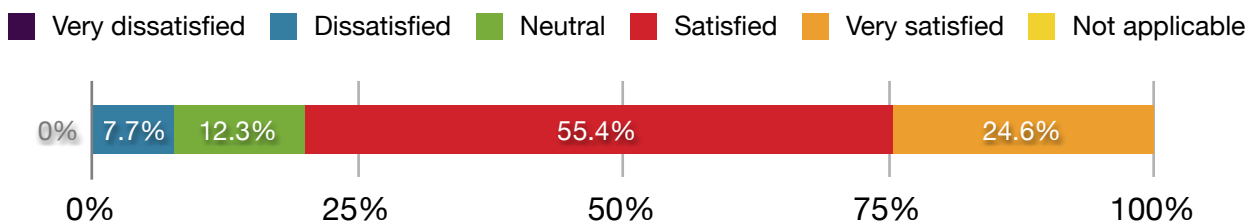
b) learning facilities at your law school, such as lecture halls and classrooms?

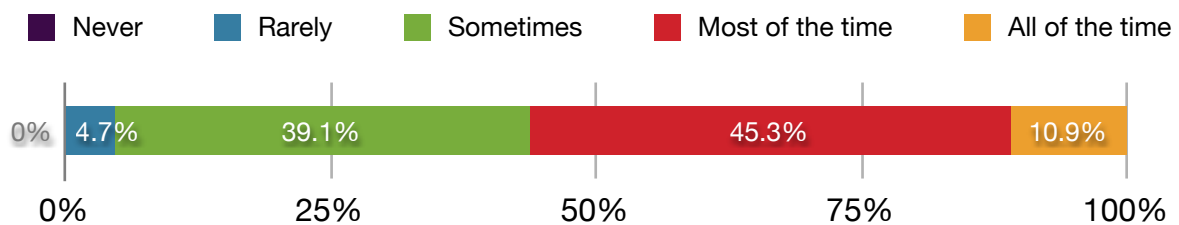

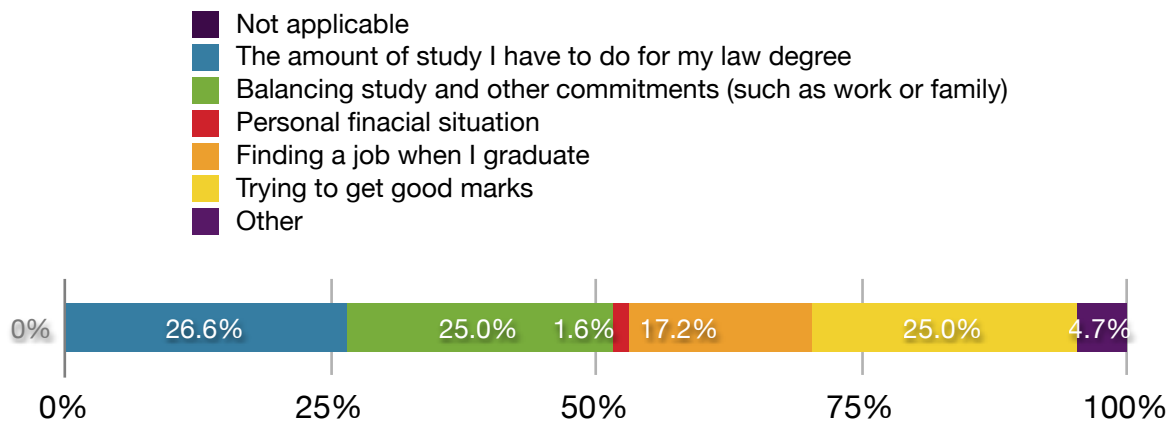
Question 32: How often do you feel stressed at law school?

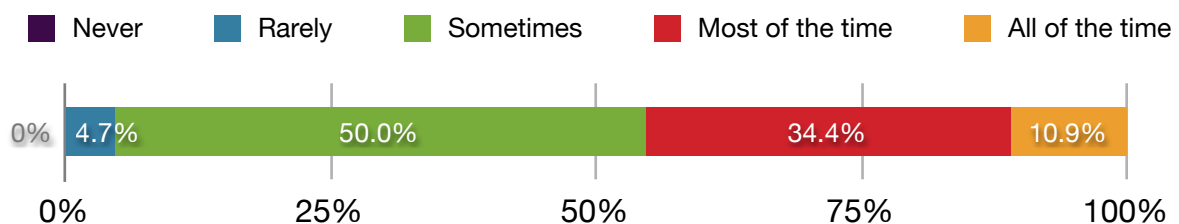
Question 33: Which of the following causes you the greatest amount of stress?

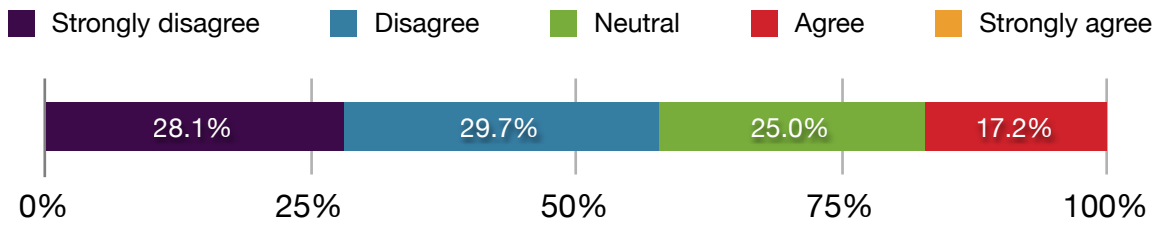
Question 34: How often do you feel overwhelmed by your workload at law school?

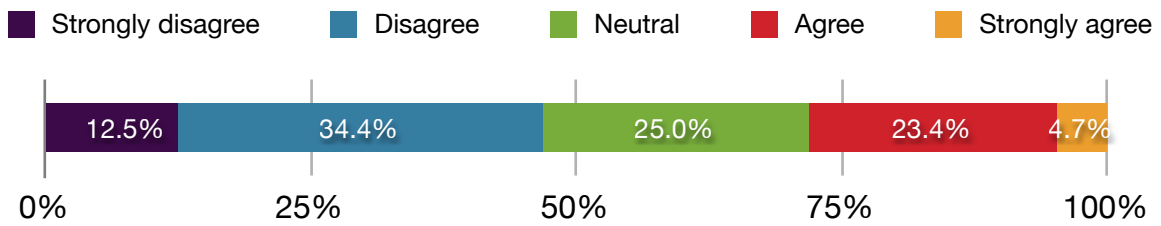
Question 35: I would feel comfortable seeking support from law school staff if I was anxious, depressed or struggling psychologically.

Question 36: I would feel comfortable seeking support from other law students if I was anxious, depressed or struggling psychologically.

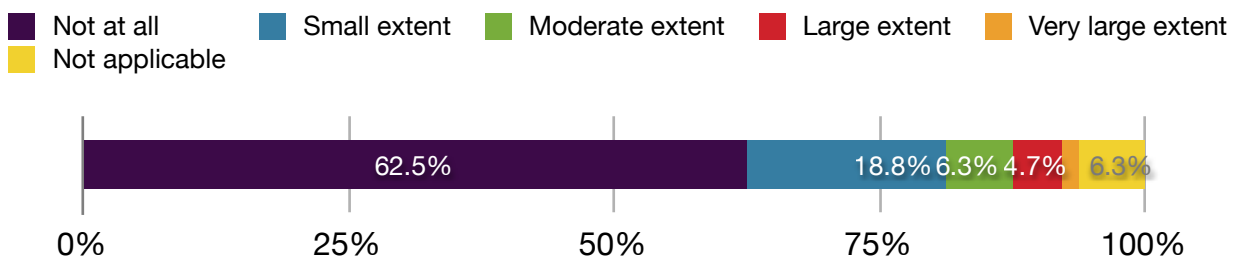

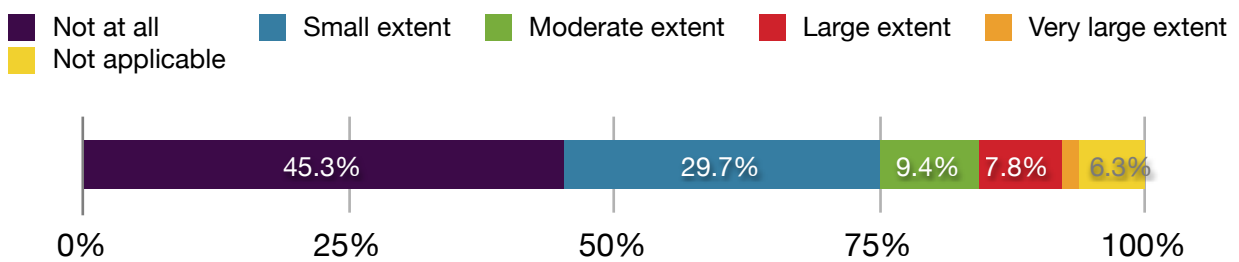
Question 37: To what extent have you used university provided:

b) Peer mentoring

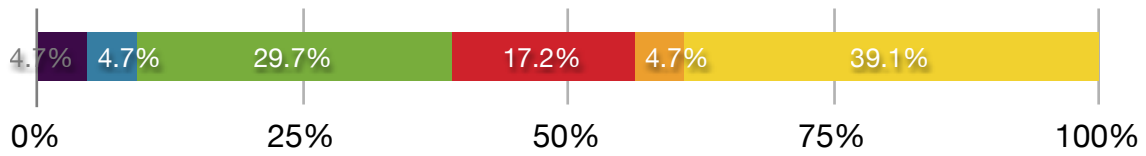

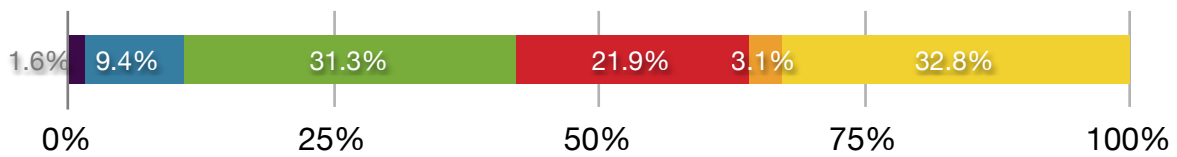
a) Counselling

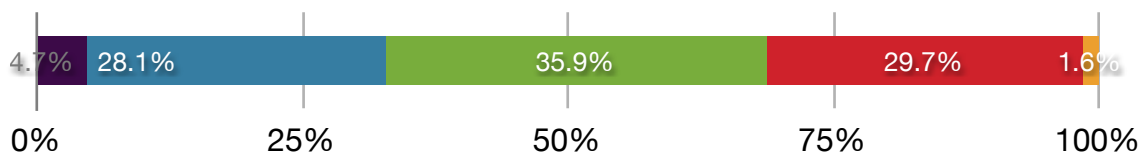

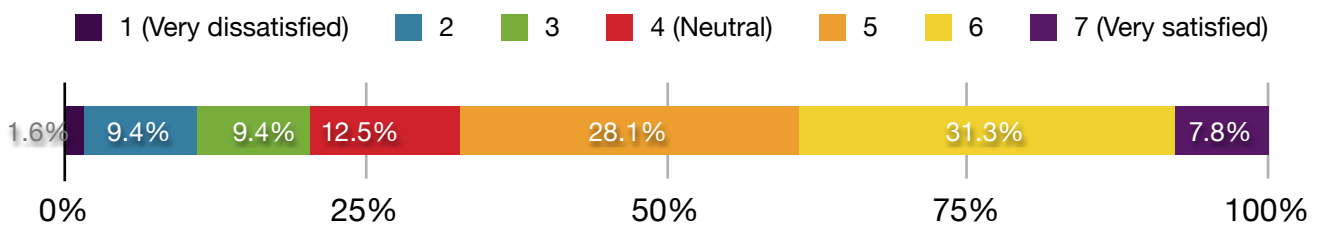

Question 41: What do you like best about your law school and why?

- Good reputation - mostly good teaching staff - strong theoretical focus
- I like the UQ Clinical Legal Education program, the most important thing has to be work experience and CV building and the CLE allows students to work at interesting firms and gain experience in a broad range of practice areas, such as medical negligence, environmental law and immigration law.
- The prestige of a sandstone university, the (non law) extra curricular activities and the friendliness of the library staff. I appreciate the use of lectopia as well, because I don't often go to classes.
- Use of lecture recording technology.
- The UQ campus is amazing and my lecturers are all nice and approachable.
- The excellent reputation and well-regarded law society. The UQ Law Society events are awesome.

Question 42: What about your law school would you most like to see improved and why?

- More varied types of assessments and more interaction between students and other students/lecturers
- Assessment feedback - we need personalised feedback, general feedback doesn't mean much
- A greater focus upon networking with potential future employers and practical legal skills would be appreciated.
- Assess us more on the tutorials so that we may know exactly where we're going wrong if we're making mistakes throughout the semester instead of only allowing consultations the week before exams.
- Lecturers must be more willing to provide feedback on assessment. It is hard to seek advice on where to improve results because Lecturers generally seem to not care about a student's results.
