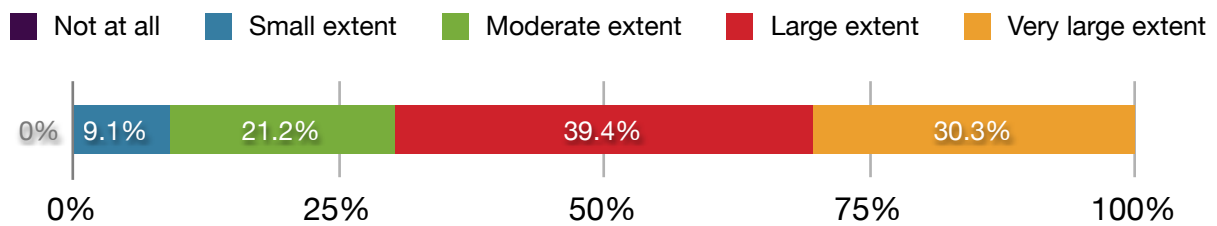

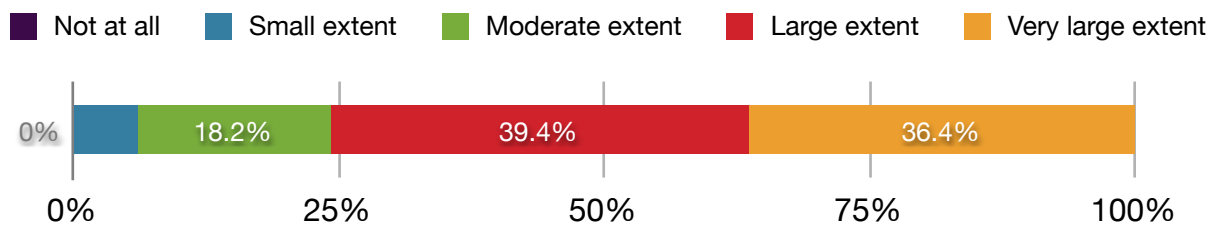

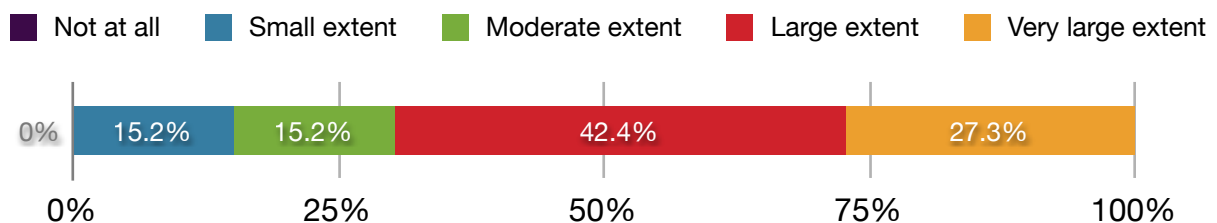
a) Shown that they care about your learning outcomes?



b) Been helpful and approachable?



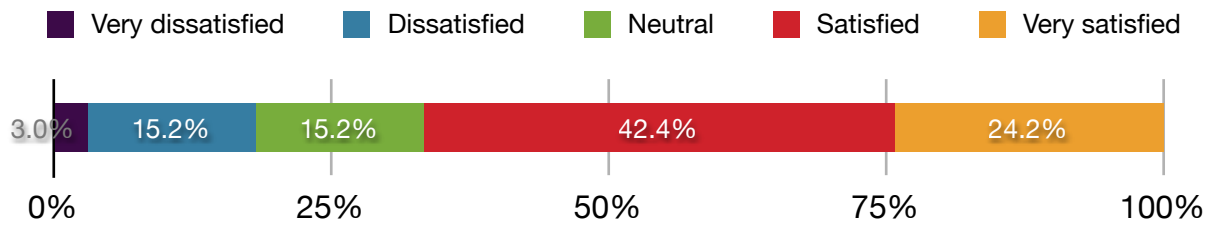
c) Created an engaging learning environment?



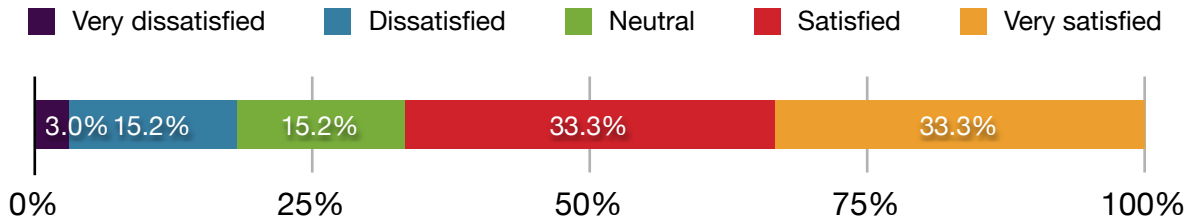

a) The quality of the feedback that you receive on assessments?

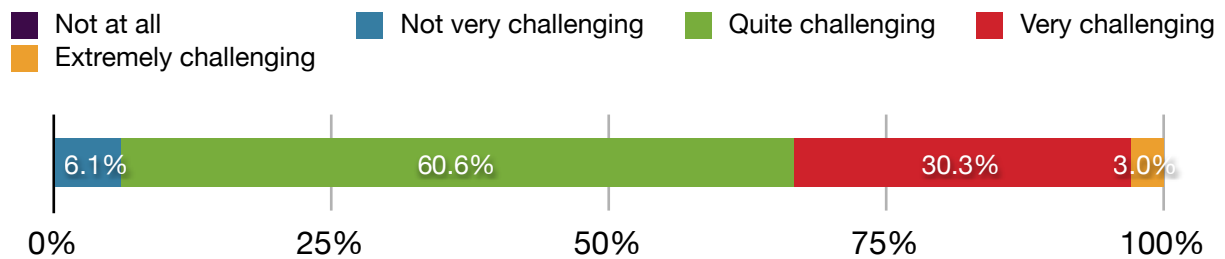


b) the timeliness of the feedback that you receive on assessments?



Question 14: How challenging have you found your assessments?

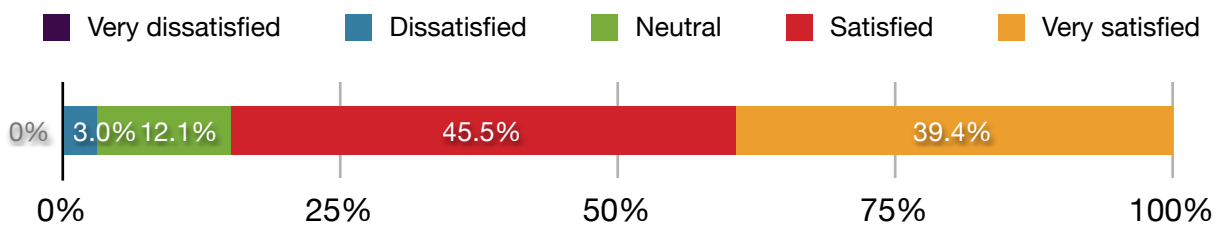

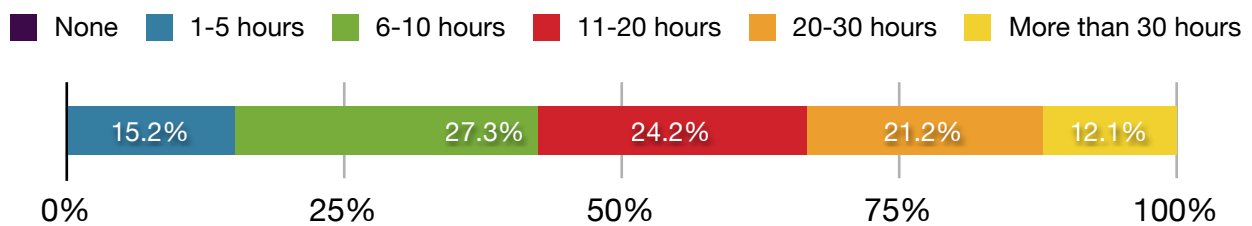

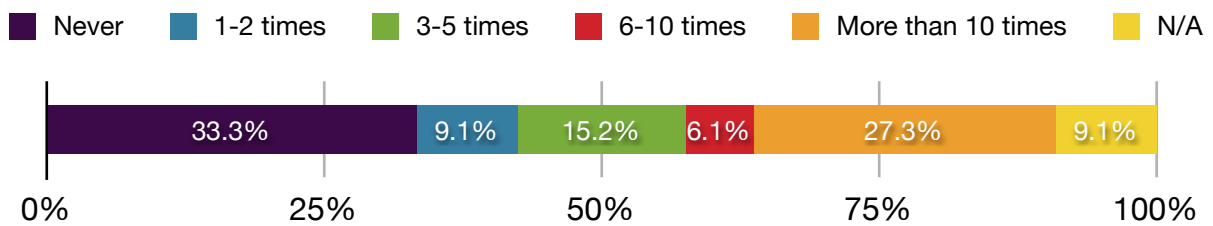
Question 16: During semester, how many hours do you spend studying (including preparing for class) each week?

Question 17: How often do you visit your law school/university library (as opposed to using online library resources) in a typical semester?

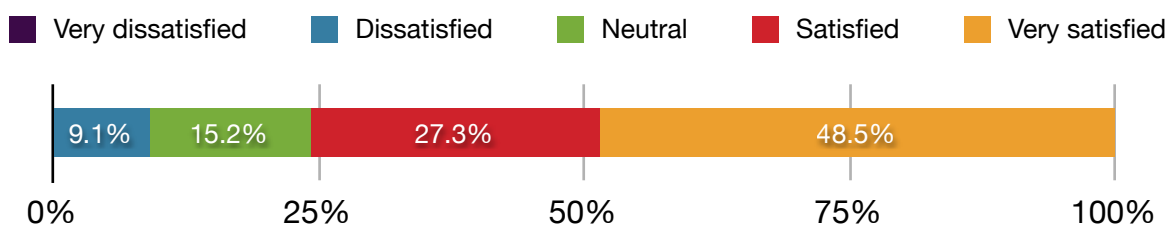

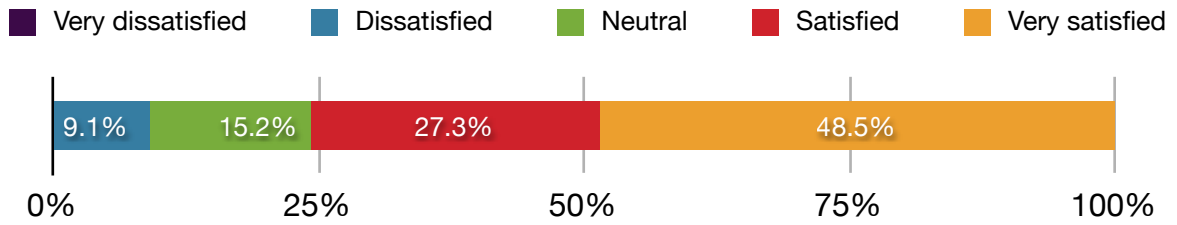

a) The range of elective subjects available?



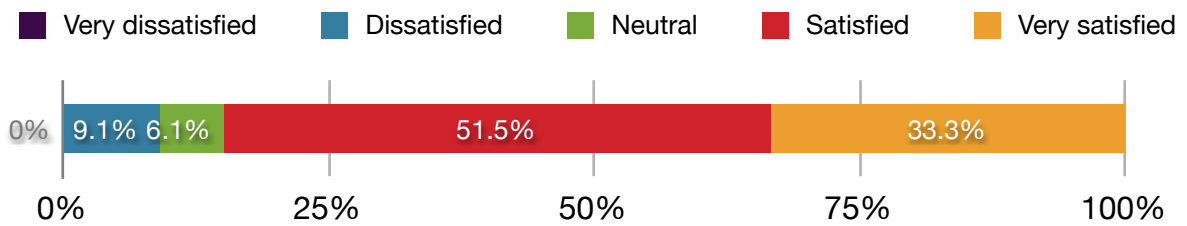
b) The online resources available to support your study, such as study forums?

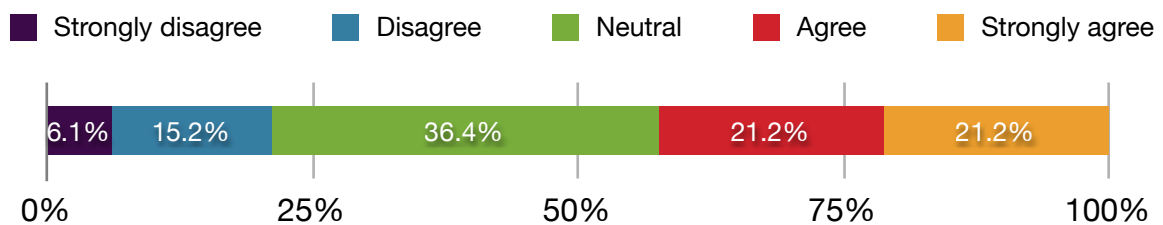

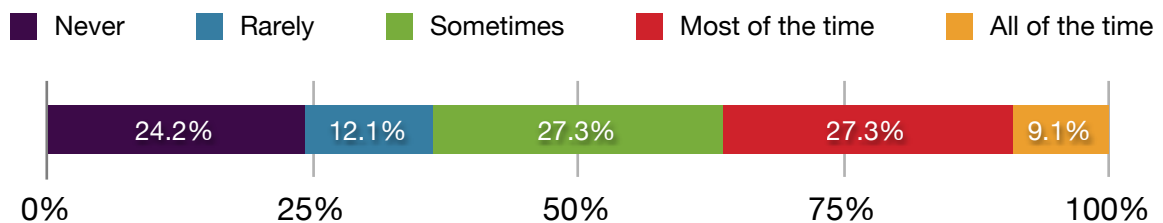
Question 20: I believe my law school is highly regarded by employers.

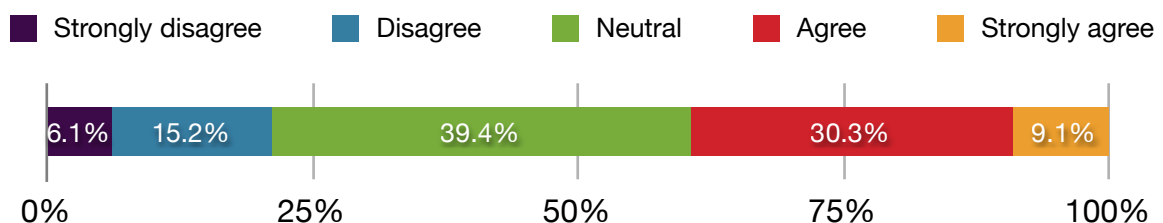
Question 21: How often do you feel stressed about finding a relevant job after you graduate?

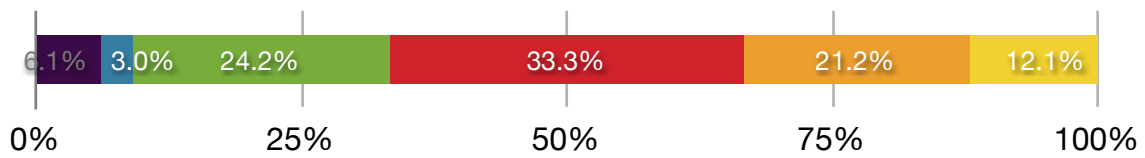

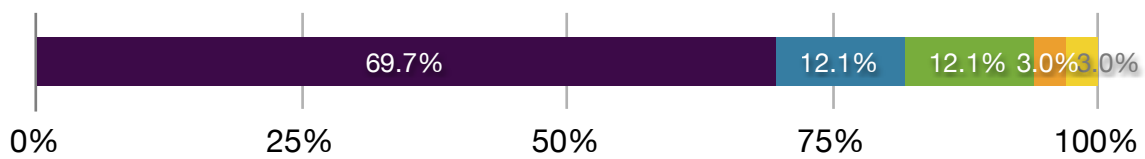

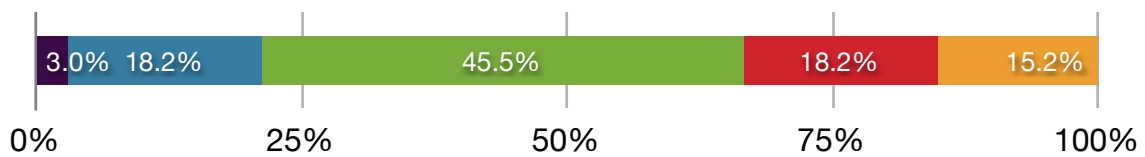

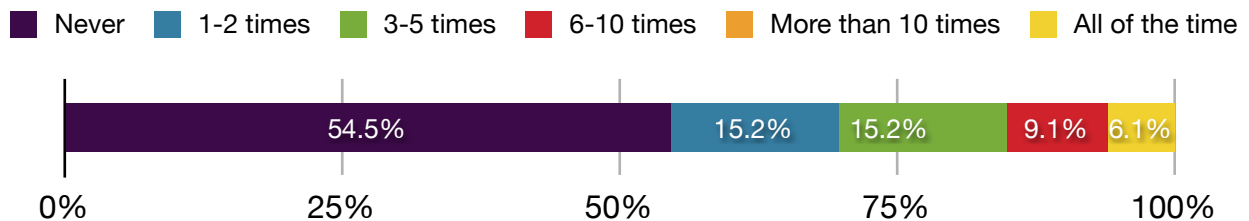
Question 26: I enjoy spending time on campus at my law school

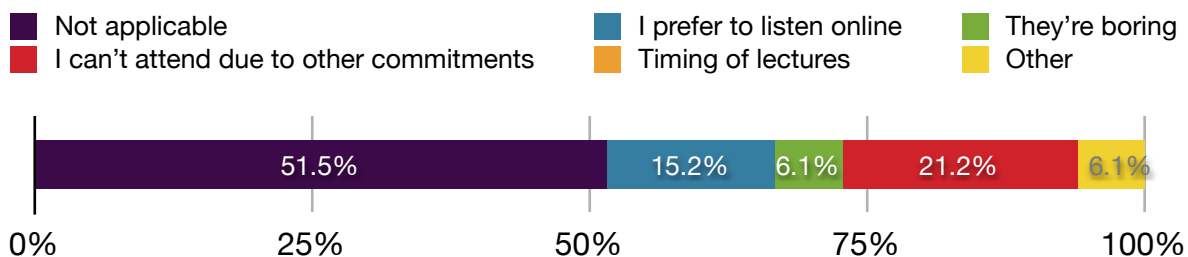
Question 27: How often do you skip lectures in a typical semester, other than as a result of illness?

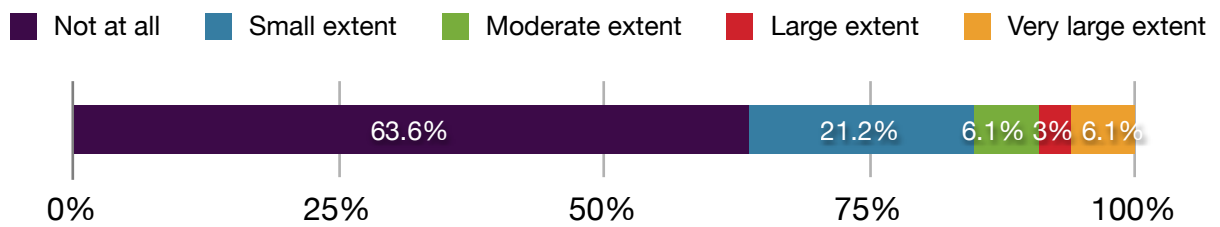
Question 28: What is your main reason for skipping lectures?

Question 29: To what extent have you taken part in extra-curricular activities such as legal competitions, social events and clubs at your law school?

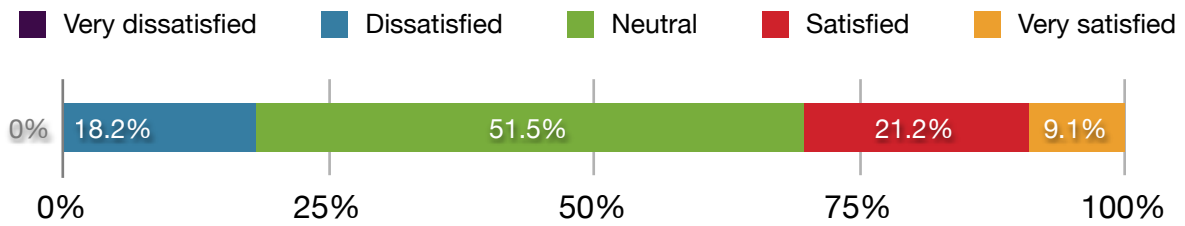

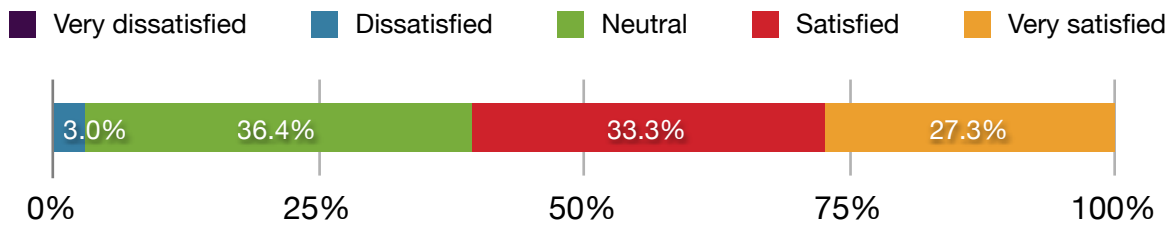

a) the range of extra-curricular activities available at your law school?



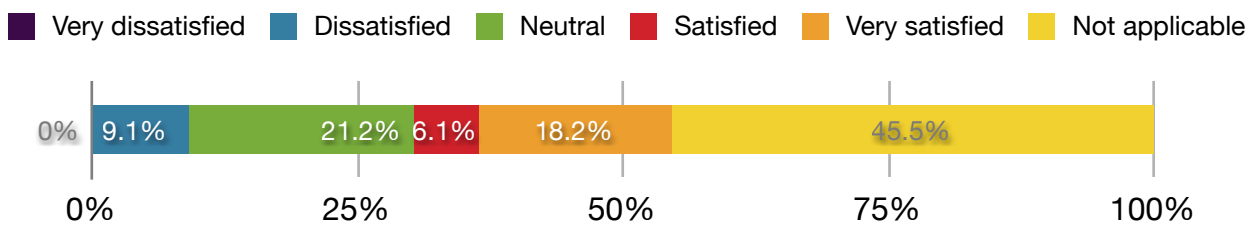
b) learning facilities at your law school, such as lecture halls and classrooms?

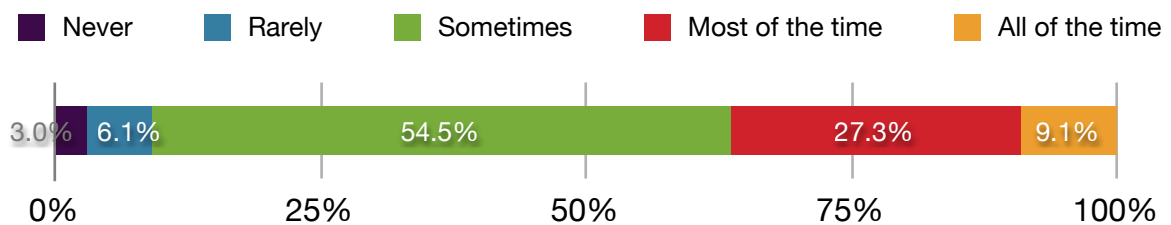

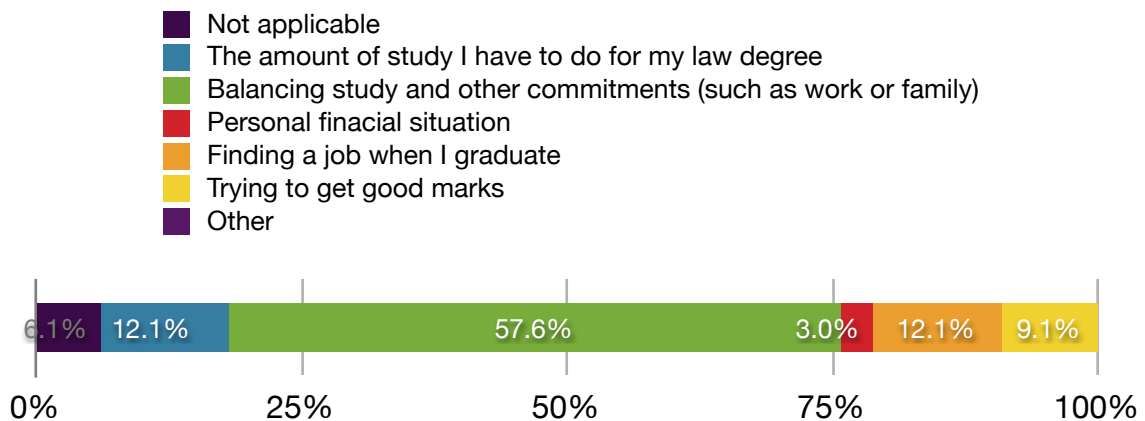
Question 32: How often do you feel stressed at law school?

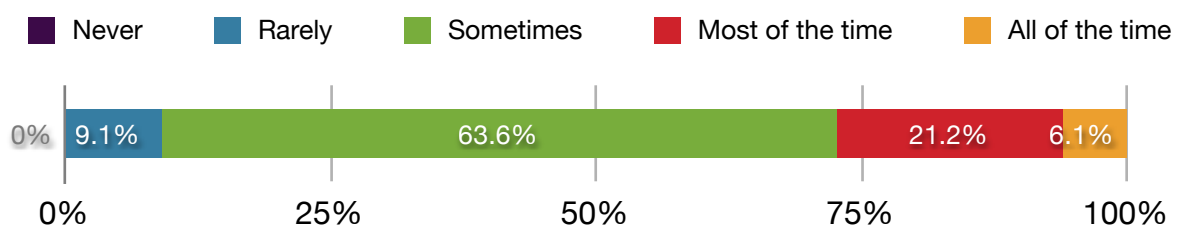
Question 33: Which of the following causes you the greatest amount of stress?

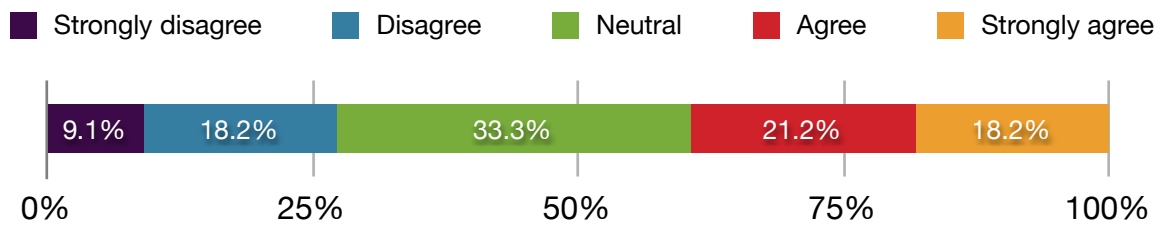
Question 34: How often do you feel overwhelmed by your workload at law school?

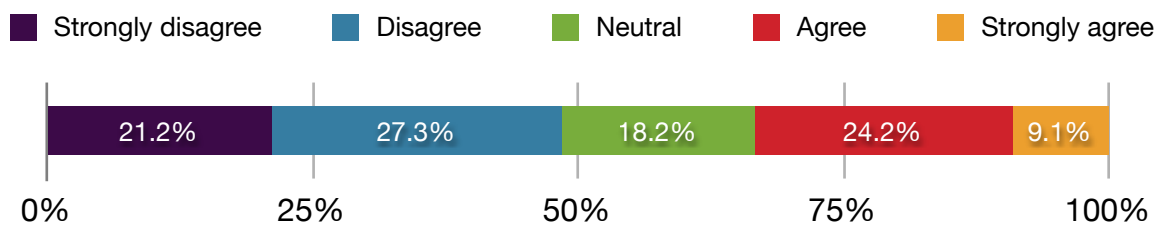
Question 35: I would feel comfortable seeking support from law school staff if I was anxious, depressed or struggling psychologically.

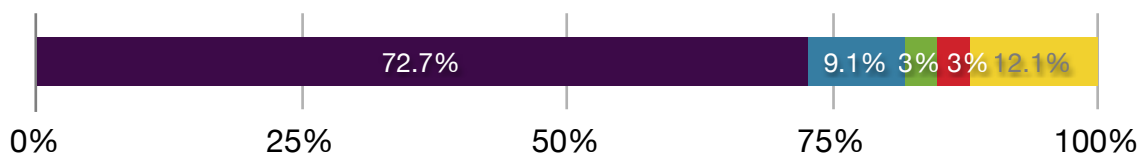

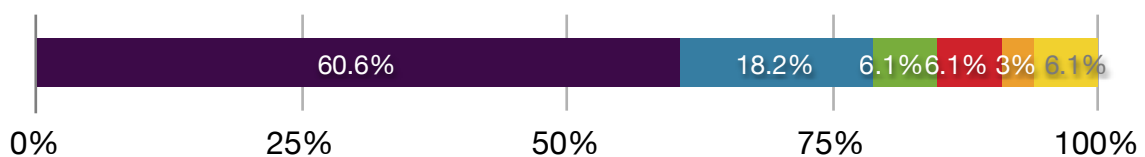

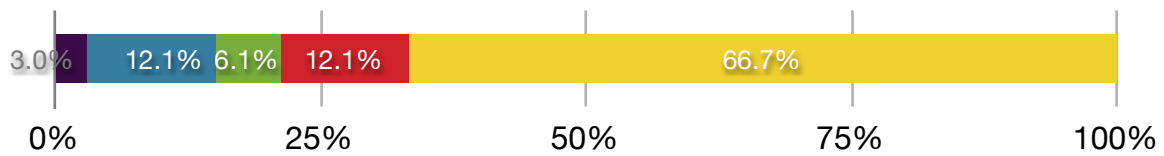

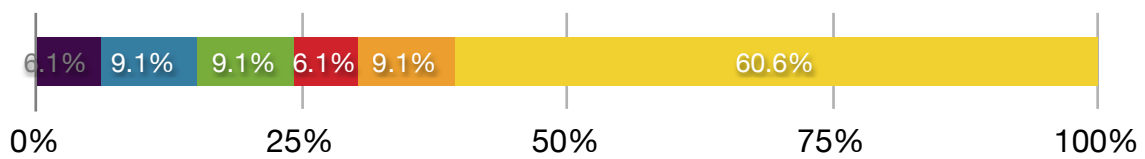
a) Counselling

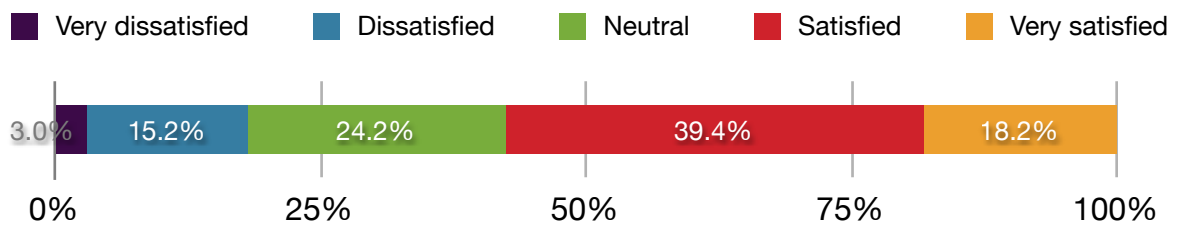

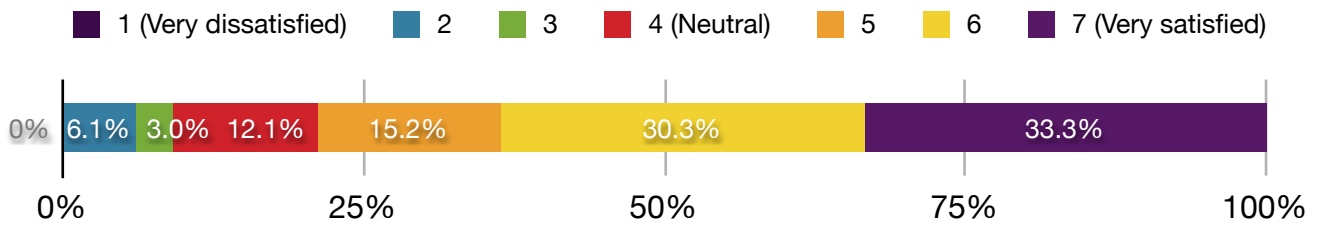

Question 41: What do you like best about your law school and why?

- I like the fact that I can study when it suits me, meaning I can focus on my studies when I come home from work and the kids are in bed.
- The lecturers want you to succeed, it is very community based. Everyone is supportive and there is a wealth of information in the library.
- Availability to study online/distance regardless of location so that I could take on full time work
- I love the small classes, the interaction with lecturers and other students. The content is modern, innovative and practical.
- The external program is very well done! I feel that when I need it, the lecturers will be able to assist me when needed and also in a timely fashion.

Question 42: What about your law school would you most like to see improved and why?

- I would like to see more subjects offered over the summer semester to enable part time students to be able to complete the degree sooner. By the time I have finished my degree it will have taken me about six years to seven years to complete part time which is a long time to be studying. I now find myself pushing myself a little harder over the course of two semester's so that I can complete it in the next couple of years.
- More mock trials and practical assessment as opposed to theory
- Better communication and assistance to external students. I don't feel like I'm a part of it at all.
- I would like to see more instance where external students are involved in campus life. Perhaps on campus workshops or perhaps an on campus or online meet an greet.
- I would like to see it better recognised by the legal community.
